Forest Heights to Be Hijacked Again on Tomorrow!

On tomorrow, for the third time within one year, our town will be politically hijacked. The election that is scheduled for tomorrow is without a doubt, illegal and a direct violation of our town charter. In fact, the Court may well declare the election null and void within the near future.

Nevertheless, should you decide to participate in the electoral process as a demonstration of your commitment to try and have some say so in your town, we offer these thoughts on what you should do.

1. Exercise your right to write in the only legally appropriate choices for Mayor and Ward III council seat. Write in Mayor Myles Spires for Mayor and Councilman Worthington Ross for Ward III Town Council. This should stop the hijacking.
2. Should you wish to move in an alternative way, here is the lineup of the candidates as presented on the illegal ballot.

QUINCY HINES - Without a doubt, Mr. Hines is the only candidate on the ballot that may be deserving of our vote. He has served on the Town Council before, has no connections to any of the hijackers, and probably has a good chance of re-

establishing a good relationship with Annapolis so that the town can receive the funding that is needed to function properly.

Andrea McCutcheon – Under no circumstances should a vote be cast for this person. She is probably the most treacherous of all the hijackers. In the September 7, 2006 blunder, she teamed her treachery with Larry Stoner's vendetta to make the move on Mayor Spires. But now, she refers to Larry Stoner as the "self appointed acting mayor"
