FIRST MINT

First mint to make coins in the Western Hemisphere was opened by the Spanish, located in Mexico City in 1536. The first coin produced was the Piece of Eight also called the Spanish Dollar. By 1630s the coin Piece of Eight was being circulated in the first English Colonies in Jamestown, VA and St. Mary's, MD. In order to make change the coin was cut into eight pieces or bits, two bits equaled a quarter of the Spanish Dollar. (slang term for a quarter is two bits). In 1658 Cecil Calvert had his own coins made in England for use in Maryland, termed the Baltimore shilling. Calvert's many enemies in England filed criminal charges accusing him of circulated false money, case was dismissed. May 1661 the Maryland Assembly passed a law establishing a mint in Maryland.

SNOW PARKING RESTRICTIONS

Town Ordinance Section 15.3.2 in order to effectively clear our streets during snow conditions: "Except as indicated by legally posted signs, it shall be unlawful to park on the side of any street opposite the street light poles during a snow emergency." In other words, simply park on the light pole side of the street, unless restricted by **NO PARKING** signs. Note: If the snow plow is blocked by your car, the fine is \$35.00 plus impoundment of your vehicle.

It's important to use trash containers with lids

All mixed combustibles and non-combustibles including garbage, household trash, paper, rags, and cardboard. Trash should be placed within two feet of the curb line.

The County also collects recyclable materials in the Town on **MONDAY** (plastics, newspapers, etc.)

Every WEDNESDAY, tree trimmings, grass and leaves will be picked up, provided they are no longer than 4 feet and tied in small bundles & grass clippings should be in trash bags.

Whenever Prince George's County Government holidays are celebrated on a Tuesday or Friday, trash will not be picked up on those days, nor will there be a make up date. However, trash will be picked up on the next regular scheduled pick-up date. Your cooperation with Town Ordinances for disposing of residential trash is important for maintaining health and property values in the Town

ELECTION INFORMATION

Filing Deadline for Candidates is **APRIL 1, 2005**

Forest Heights residents who plan to be CANDIDATES for the office of Mayor or Town Council Member in the coming town election are reminded that they must file a Certificate of Nomination at the administrative office at 5508 Arapahoe Drive on or before **Friday, April 1, 2005**. Filing of such a Certificate constitutes a filing for office provided the candidate is otherwise qualified.

The Town Charter provides that all candidates shall have resided in the Town for at least one year immediately preceding the election, shall be qualified voters of the Town and shall maintain a permanent residence in the Town during their term in office. Candidates for Town Council may seek office only for the Ward in which they reside and shall have resided in that Ward for at least one year preceding the Town Election.

CANDIDATES STATEMENTS

Candidates in the May 2005 Town Election must have their statements for the April Newsletter in to the Town Clerk by Friday, April 1, 2005.

VOTER REGISTRATION

Every person who is a citizen of the United States, is at least 18 years of age (or will be at the time of the Town Election), and has been a bona fide resident of the Town for at least 30 days at the time of election, is qualified to register in Prince George's County, Maryland, with the Board of Elections Supervisor. Only those who are registered voters will be eligible to vote or run for office in the Town Election.
